- 1. Input and discussion on the River Visioning Plan. Eric McCulley from River Restoration addressed the City Council and citizens. He said they help communities develop connections to their rivers. He has been working with Green River City to develop recreational activities along the Green River. He explained the river visioning plan that River Restoration came up with and said the purpose of this meeting is to inform the public of what they have developed and suggested so far and would love any comments. The three main areas of interest is the Main Street area, Riverside Park and the I-70 corridor. He mentioned the grants that are available to help the city accomplish these goals. The next steps are an Open House and maybe that can be held in conjunction with the River Festival. Identify individual roles for people who are interested such as writing grants, help put in bike trails, maintaining some of the areas around the museum, and other things like that. Identify grants and potential matching funds. Some of the grants do not require matching funds. If you work together you can find this vision. He took questions and comments from those present.
- 2. Discuss problems and concerns with softball tournament at Melon Days. Conae Black said this was an agenda item request from Leiann Chidester who is not present. Jackie Nelson said she could speak in her behalf. She collected a five gallon bucket full of balls plus more that came over into her yard from the ball games. There were balls that were hitting neighbor's cars. She was scared that a ball was going to take out a window. She is not against the ball tournament but would like more protection of private property. Members of the Council were glad that they were made aware of the situation and will work at addressing the problem. The discussion included problems with the garbage and overnight campers at the ball parks.
- 3. Report from Acting Fire Chief Ben Lehnhoff. Chief Lehnhoff said the fire department would like to honor Fire Chief Philip Engleman by putting his name on the side of the new building that is large enough to see from the road as you drive by. They provided a few ideas. He said that Philip Engleman was the driving force in obtaining this new building. He asked the Council to consider this request.
- 4. <u>Discuss/approve/deny consent agenda</u>. **MOTION**: Penney Riches made a motion to approve the consent agenda with corrections to the minutes. Kim Andrus seconded the motion. **VOTE**: Penney Riches, Kim Andrus, Kathy Ryan and Anna Evans voted age. The motion carried.
